The elites of the Government and the Judiciary who took the space of the former Maputo Fish Market

•Former governors, counselor judges, plus a former PGR, occupied the space that once operated the Maputo Fish Market. The space is claimed by former sellers who, for more than 35 years, occupied it in good faith and developed their seafood activities. What these poor sellers don't know is that the space is in the hands of influential figures in the corridors of justice, so any legal battle is doomed to failure.





•The elite that is developing a real estate project (building for housing and commerce) have the protection of the Municipality of Maputo, which on several occasions came to the public to defend that there is no room for compensation for former sellers. The Police, for their part, have done their utmost to prevent peaceful demonstrations by former vendors claiming acquired rights over the space.



n the place where the Maputo Fish Market operated for decades, in an informal way, a real estate project is being born, whose works started in May 2022 and end in May 2024. The residential and commercial building, which is a few meters of Marginal de Maputo, is owned by Cooperativa Vila Praia, Lda, a limited company incorporated in May 2020, with a share capital of 500,000 Meticais.

Cooperativa Vila Praia, Lda has 10 members, each with a stake equivalent to 50,000 Meticais. On one hand, it is not new that the space disputed by the former vendors had been allocated to the Frelimo elite, on the other hand it's surprising to see the presence of former members of the Government, adviser judges (in active and retired), former Attorney General of the Republic and academics in the shareholder structure of Cooperativa Vila Praia, Lda.

The certificate issued by the Registry of Legal Entities contains the names of Alberto Vaquina, former Prime Minister; Augusto Paulino, former Attorney General of the Republic; Ernesto Gove, former Governor of

the Bank of Mozambique; Jorge Ferrão, former Minister of Education and current Rector of the Pedagogical University of Maputo; Machatine Munguambe, former President of the Administrative Court; and Ozias Pondja, former President of the Supreme Court and current Counselor Judge of the Constitutional Council..

As can be seen, Cooperativa Vila Praia summarizes the promiscuity of holders of sovereign bodies in business. Four holders and former holders of sovereign bodies (Alberto Vaquina, Jorge Ferrão, Machatine Munguambe and Ozias Pondja) are brought together in a single company. It is these figures, including Augusto Paulino (former PGR), who make Cooperativa Vila Praia, Lda into an "armored" company against any lawsuit or legal dispute.

Therefore, it is easy to conclude how the struggle of the sellers of the old Fish Market will end, who today demand compensation for their withdrawal to the new Fish Market. These are men and women who for over 35 years have occupied a space for the informal sale of seafood. The previous arket "A Luta"



Continua" became a reference in the capital and later became known by the name of Mercado de Peixe. In order to create better conditions for the treatment, conservation and sale of seafood, the Municipality of Maputo built a new Fish Market, on Marginal Avenue, with funding from the Government of Japan.

In 2016, all sellers from the old market were transferred to the new Fish Market, where they carry out their activities under better conditions. However, the sellers demand compensation for the "expropriation" of the space where the former Fish Market used to be. The space was assigned to an elite that includes magistrates and governors, but the sellers consider themselves legitimate own-

In fact, one of the ways of acquiring the Right of Use and Benefit of Land (DUAT) is the occupation by national individuals who, in good faith, have been using the land for at least 10 years. The former sellers occupied the space in good faith and carried out their activities there uninterruptedly for over 35 years. Their transfer to a new market should not imply, in their view, the loss of acquired rights over the space where they worked.

Meanwhile, the Municipal Council of Maputo, Eneas Comiche, argues that there is no need to pay any compensation to the vendors. Using the Posture on Markets and Fairs, Comiche made it clear that the occupation of sales outlets in the markets has a precarious nature, with the improvements made to the Municipality. "For reasons of force majeure, or the need to carry out works, the Municipal Council may suspend the authorizations or adjudications made, without the right to any compensation from the sellers".1

Contrary to the sellers who claim ownership of the space, the mayor of the capital said, in a session of the Municipal Assembly of Maputo, that the space belongs to the Municipality and that it is up to them to determine the destination. "During the process of integration into the current Fish Market, all vendors signed the respective term of delivery of the kiosks. Regarding the destination of the space where the Luta Continua market once operated, we understand that it belongs to the Municipal Council and it was up to this institution to determine the destination to be given, either for public use or for a public-private partnership".2

And the determined destination was to allocate the space to Cooperativa Vila Praia, Lda, which is developing the real estate proj-

ect called "AURA", which consists of a mixed building for housing and commerce. In addition to excluding the payment of compensation, the Municipality of Maputo and the Police of the Republic of Mozambique (PRM) have been making the protesting sellers' right to demonstrate unfeasible.

For example, on August 17, 2022, the PRM, through the Rapid Intervention Unit (UIR), illegally prevented a demonstration by the fish market vendors. The group had communicated to the Maputo Municipal Council, on August 4, 2022, of its intention to take to the streets to demonstrate against what they consider to be an injustice. The Municipal Council did not present any objection to the holding of the aforementioned demonstration.

Under the law, failure to notify the promoters within two days of the decision to ban the demonstration must be considered as the absence of any objection on the part of the authorities. In other words, silence constitutes a true tacit acceptance. However, on the appointed day and time, a contingent of the UIR appeared to prevent the march from taking place, an action that constitutes a serious violation of the right to freedom of assembly and demonstration enshrined in the Constitution of the Republic of Mozambique (CRM).
